

Privacy Policy

This Privacy Policy is meant to help you understand what information we collect, why we collect it, and how you can update, manage, export, and delete your information.

We build a range of services that helps our Members to be informed daily about the information of our club's activities and events, interact with other members of our club in new ways. Our services include:

Android Apps, IOS Apps, Website and Devices

You can use our services in a variety of ways. For example, you can sign up in our mobile app or website for your membership account to manage your membership dues payments, online bookings and to know the latest information about upcoming events and recent activities.

To help explain things as clearly as possible, we've added examples, explanatory videos, and definitions for key terms. And if you have any questions about this Privacy Policy, you can contact us.

INFORMATION RAJPATH CLUB COLLECTS

We want you to understand the types of information we collect as you use our services.

We do not collect or store any information from our website or our mobile apps whether our members are signed in at the portal or any other persons visiting to our website or other portals.

We'll ask for your consent before using your information for a purpose that isn't covered in this Privacy Policy.

SHARING YOUR INFORMATION

We don't disclose any kind of confidential information of your account that includes user id password, contact numbers etc. to anyone in the market. If they have it from other resources, We, RAJPATH CLUB LIMITED, is not responsible for any kind of disclosure or misuse.

With domain administrators

They may be able to:

- Access and retain information stored in your account, like your email.
- View statistics regarding your account, like how many apps you install.
- Change your account password.
- Suspend or terminate your account access.
- Receive your account information in order to satisfy applicable law, regulation, legal process, or enforceable governmental request.
- Restrict your ability to delete or edit your information or your privacy settings.

FOR EXTERNAL PROCESSING:

We provide personal information to our affiliates and other trusted businesses or persons to process it for us, based on our instructions and in compliance with our Privacy Policy and any other appropriate confidentiality and security measures. For example, we use service providers to

help operate our data centres, deliver our products and services, improve our internal business processes, and offer additional support to customers and users.

FOR LEGAL REASONS:

We will share personal information outside RAJPATH CLUB LIMITED if we have a good-faith belief that access, use, preservation, or disclosure of the information is reasonably necessary to:

- Meet any applicable law, regulation, legal process, or enforceable governmental request. We share information about the number and type of requests we receive from governments in our Transparency Report.
- Enforce applicable Terms of Service, including investigation of potential violations.
- Detect, prevent, or otherwise address fraud, security, or technical issues.
- Protect against harm to the rights, property or safety of Rajpath Club Limited, our users, or the public as required or permitted by law.

If Rajpath Club Limited is involved in a merger, acquisition, or sale of assets, we'll continue to ensure the confidentiality of your personal information and give affected users notice before personal information is transferred or becomes subject to a different privacy policy.

KEEPING YOUR INFORMATION SECURE

We build security into our services to protect your information

All Rajpath Club Limited products are built with strong security features that continuously protect your information. The insights we gain from maintaining our services help us detect and automatically block security threats from ever reaching you. And if we do detect something risky that we think you should know about, we'll notify you and help guide you through steps to stay better protected.

We work hard to protect you from unauthorized access, alteration, disclosure, or destruction of information we hold, including:

- We use encryption to keep your data private while in transit
- We offer a range of security features, 2 Step Verification to help you protect your account
- We review our information collection, storage, and processing practices, including physical security measures, to prevent unauthorized access to our systems.
- We restrict access to personal information to employees, contractors, and agents who need that information in order to process it. Anyone with this access is subject to strict contractual confidentiality obligations and may be disciplined or terminated if they fail to meet these obligations.

EXPORTING & DELETING YOUR INFORMATION

Only authorised employee and system administrator can export or delete your information as per their rights allotted.

COMPLIANCE & COOPERATION WITH REGULATORS

Data transfers
